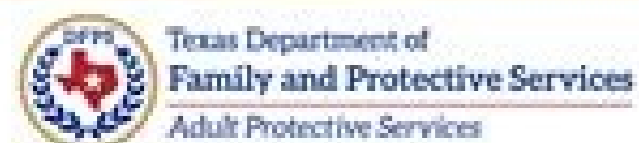

A TEXAS EDUCATOR'S GUIDE TO REPORTING SUSPECTED ABUSE AND NEGLECT

FACULTY RIGHTS & RESPONSIBILITIES

- You have a right and responsibility to report suspected abuse or neglect free of fear, retaliation, or reprimand.
- Your report of child abuse or neglect is confidential and immune from civil or criminal liability as long as the report is made in "good faith" and "without malice."
- Education professionals may not designate this duty to report suspected abuse or neglect to any other person.
- Individuals making reports of suspected abuse or neglect are not required to identify the suspect to a peer, colleague, or supervisor.
- If you suspect that your identity be kept confidential, CPS may not assign your identity to the child's parents, to report perpetrators, or to others without consent or a court order. However, they may disclose your identity to the district attorney or law enforcement if the case requires further investigation.
- When responding to an inquiry, let the child use his or her own words to tell you what happened, but have the detailed questioning to the professional. This is critical to ensuring the integrity of any investigation and ensuring additional reports to the state.

ADMINISTRATION AND STAFF RIGHTS & RESPONSIBILITIES

- You have the same rights and responsibilities as faculty members.
- Employees of personnel are formally trained on an annual basis and presented to deal with suspected abuse.
- There are steps you can take to ensure the confidentiality and anonymity of the reporter.
- Do not discuss the report or the reporter.
- You are not required to disclose knowledge of a report to a parent or caregiver, if asked, if they do not have any knowledge of the report.
- CPS or law enforcement may still your campus during the course of an investigation. Avoid the use of public media, the internet, or social media to discuss the report.
- Establish a secure, private location where your campus where both reporters and/or students can confidentially meet with CPS or law enforcement.

HOW TO RESPOND IF A CHILD REVEALS ABUSE OR NEGLECT

- Remain calm.
- Assess the safety of the child, but do not make promises.
- Assure the child that he/she did the right thing and is not to blame for the abuse.
- Let the child tell you about the experience, but have someone to assist.
- Report the abuse to CPS or law enforcement within 48 hours.
- Out of the presence of the child, make notes about the child's engagement in the report you are asked for a statement as a law firm.

If a call to the DFPS hotline leads to the opening of an investigation³ the following information is³ useful. Abuse of children in nurseries or treatment centers. The CPS Family Helpline for Strong and Insecure Families can help you with questions like "What does a CPS research³ involve? "As citizens, communities, and leaders, we have a responsibility now more than ever to take action and be sensitive and responsive to the needs of parents and families to prevent and mitigate any greater potential risks that we anticipate given the additional stress on individuals, families, and systems." How⁴ the COVID-19 pandemic is affecting cases of child abuse and neglect. Call your local police agency or 911 right away if you have an emergency or³ life-threatening situation. These reports are investigated by HHSC Provider Investigations, not DFPS. Reporting suspected abuse makes it possible for a family to get help. Anyone who does reporting alleged abuse may be held liable for a misdemeanor or felony. Are you looking for specific help with CPS problems? "In times of social isolation and shelter order, abuse can become even more hidden and make abusive situations more serious", said Phillips. Reporting Child Abuse and Neglect Do you suspect someone of child abuse or neglect? Texas law requires that anyone who suspects that a child or other vulnerable person is being abused or neglected must report such incidents. Abuse of adults and children who live in state facilities or are being helped by programs for people with mental illness or intellectual disabilities. In a recent statement, TexProtects CEO Sophie Phillips reminded Texas that now, more than ever, is the time to keep our eyes on our most vulnerable children. The time frames for investigating reports are based on the seriousness of the allegations. Both are available 24 hours a day, 7 days a week. complaints are made about an immediate threat to the health, safety, well-being or life of the child; Report of abuse or neglect that occurs within 12 months of another investigation of abuse or neglect; or Report of Death of a Child. Call the Texas Child Protective Services hotline at 1-800-252-5400 or contact us online. We cannot accept reports by email of suspicion of abuse or neglect. On the other hand, the P2 reports require the investigator to contact the alleged victim within 72 hours. The person who reports the abuse in good faith is exempt from civil or criminal liability. Call the Office of Consumer Relations - Texas Department of Family and Protective Services at 1-800-720-7777 during regular business hours or by email protected). Every adult in Texas is an authorized child abuse and neglect reporter, so if you suspect abuse, please report³. Anyone who has reasonable cause to believe that a child, or a person of 65 years or older, or an adult with a disability is being abused, abused, or exploited must report it to DFPS according to Texas law. Not all calls to the hotline result in DFPS opening an investigation. Visit their website here. We don't handle individual cases. Once the report is received and classified according to the type of abuse or neglect reported, priority level 1 (P1) or priority level 2 (P2) will be assigned. The Texas Department of Family and Protective Services (DFPS) has a central place to report: Child Abuse and Neglect. The help line is answered by experienced CPS lawyers. In times of stress and hardship, such as the COVID-19 pandemic, rates of child abuse and neglect increase, although fewer cases have been reported. You can also report child abuse 24 hours a day, 7 days a week, on the ChildHelp hotline at 1-800-4-A-CHILD. Section 261.101 (a) of the Texas Family Code states: "A person who has reason to believe that a child's physical or mental health or well-being has been adversely affected by abuse or neglect by any person shall immediately make a report". Abuse or neglect may be reported to (800) 252-5400 or online at TxAbuseHotline.org. P1 reports require that a DFPS investigator make contact with the alleged victim within 24 hours.
